TECHNICAL SPECIFICATION

(COMMUNIQUE NO. 1)

The issue of the request contains purchase, delivery and assembly of the spray-dryer to production of whole egg powder and yolk powder with the water evaporation capacity of 1500 kg/h. In particular in terms of purchase, delivery and assembly, supervision over installation and assembly of following components:

- Drying chamber 1 pc,
- Filters outside the drying chamber 1 pc,
- Component for cooling the powder 1 pc,
- Atomizing set disc spray-drying/atomizer 2 pcs,
- Automatic operating system 1 pc,
- Operating panels 2 pcs,
- Feeding pump 1 pc,
- Slit filter cleaning yolk before the spray dryer and after the pump 1 pc,
- The component of dehumidification and standardisation of processing air to water content of 3g/l
   1 pc
- CIP cleaning of drying chamber, bag filter and ducts (without CIP station and cleaning tanks) 1
- CIP pump 1 pc,
- 2 sets of filters with additional 10 pcs,
- Sifters 2 pcs or optionally 1 pc as specified in full specification,
- Buffer for powder 5m³ 1 pc,
- Gravimetric feeder for anticaking agent 1 pc,
- Construction supporting all equipment's with platforms and stairs.

## **Technical requirments:**

- Air intake system with air filtration,
- Heating of air with gas burner suitable for natural gas GZ41,5 with indirect heating.
- The cyclone situated between spray-dryer chamber and the outside bag filter,
- The rotary locks/ valves installed on the lines transporting powder,
- Pneumatic or vacuum conveyor of powder.
- · Recuperation,
- Written instruction and guides in Polish, Technical documentation in Polish,
- Equipment and access to protocol Profinet to comunicate with production line of yolk and whole
   eggs.
- Transmission of information through Profinet to communicate spray-dryer with the existing SCADA (or equivalent solution) line,
- Sharing of outputs in controller PLC, communicating alarms, critical non-conformity (min. 4 pcs.),
- Remote desktop for controlling the dryer,
- The open source codes for the controllers and program,
- Moisture analyser in-line
